- Process data from purification batches
- Serve as a shift lead during overnight and afterhours operations

- Ability to work shifts

- Ability to work weekends and holidays

- Ability to problem-solve and work independently but integrate well with small working groups and cope with a fast pace work environment
- Ability to operate pumps and valves
- Ability to retain a positive, can-do attitude under physically demanding conditions
- Familiarity with general industrial hygiene practices and safety practices
- Versed with personal computers and Microsoft Office applications
- Fluent in written and spoken English
- Eligible to work in the United States

Physical Demands of Your Job
