- Associate's degree in science, mechanics, or experience in machine operations and trade professions is preferred, but not required
- Ability to work shifts

- Ability to work weekends, nights, and holidays
- Ability to work overtime
- Ability to operate pumps and valves
- Ability to operate a forklift or pallet jack
- Ability to maintain a positive, can-do attitude under physically demanding conditions
- Capability of working in a fluid changing environment
- Familiarity with general industrial hygiene practices and safety practices
